## \$15,000 Cash Progressive Sweepstakes - Official Rules

## Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a " $\$ 15,000$ Cash Progressive Sweepstakes" promotion on select Saturday's in April. The promotional period will begin on Monday, April 1, 2024 at 5:00am and will end at 10:00pm on Saturday, April 27, 2024.
2. A total of ninety ( 90 ) winners will be randomly selected during the promotional period.
3. Five (5) winners will be selected and awarded a prize approximately every hour starting at 6:00pm and ending approximately at 9:00pm on the following dates:

- Saturday, April 13, 2024
- Saturday, April 20, 2024

4. Ten (10) winners will be selected and awarded a prize approximately every hour starting at $6: 00 \mathrm{pm}$ and ending approximately at 10:00pm on the following dates:

- Saturday, April 27, 2024

5. All times referred to throughout these rules are Eastern Standard Time (EST).

## Eligibility

1. Must be a member of the PENN Play program.
2. Must be 21 years of age or older to obtain a PENN Play card.
3. No purchase necessary to receive a PENN Play card.
4. A valid government issued photo ID may be required to verify age and identity.
5. Qualifying PENN Play members can win a total of one (1) time each promotional date.

## Earning Entries

1. For every two (2) tier points earned (\$10 coin-in) through play, PENN Play members will earn one (1) entry.
2. Entry earning will begin at approximately $5: 00$ am on Monday, April 1,2024 and will end at approximately $10: 00 \mathrm{pm}$ on Saturday, April 27, 2024.
3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by swiping at a Marketing kiosk, properly removing their PENN Play card from a VLT machine or carding out via Bluetooth connection in the PENN Play App.
4. Earned entries will be included in the upcoming drawing up to approximately five (5) minutes before each drawing time. Earned entries may be delayed posting onto a guest's account.
5. Entries will accumulate during the entire promotional period.

## Implementation

1. On Saturday, April 13 and 20, five (5) winners will be selected approximately every hour beginning at 6:00pm and ending at 9:00pm.
2. Winners will select an envelope from the prize board in the order they were selected and will be awarded the corresponding prize as indicated by the card in the envelope.
3. The prize board will contain fifty (50) envelopes and prizes will range in value from two hundred fifty (\$250) PENN Bonus Play up to five thousand $(\$ 5,000)$ cash. The following PENN Bonus Play prizes will be available: two hundred fifty (\$250) PENN Bonus Play, five hundred (\$500) PENN Bonus Play, seven hundred fifty (\$750) PENN Bonus Play, \$1,000

PENN Bonus Play. Cash prizes will be in five thousand $(\$ 5,000)$ dollar increments ranging from five thousand $(\$ 5,000)$, ten thousand $(\$ 10,000)$ or fifteen thousand $(\$ 15,000)$
4. In the event the cash prize envelope is not selected, the cash prize will roll over into the following week and will increase the following week's cash prize.
a. Example: Cash prize not selected in week one, week two cash prize will be $\$ 10,000$. If during week two, the cash prize is not selected, the $\$ 10,000$ cash prize will rollover into the next week for a total of $\$ 15,000$ in the final week should the cash prize not be selected during the first two promotion dates.
5. The cash prize must be paid out in the final week.
6. On Saturday, April 27, 2024, ten (10) winners will be selected approximately every hour beginning at 6:00pm and ending at $10: 00 \mathrm{pm}$ for a total of fifty (50) winners.
7. Winners will select an envelope from the prize board in the order they were selected and will be awarded the corresponding prize as indicated by the card in the envelope.
8. On the final week, the prize board will contain fifty (50) envelopes and prizes will range in value from $\$ 250$ PENN Bonus Play up to \$15,000 cash
a. The cash prize will be a minimum of $\$ 5,000$ and up to $\$ 15,000$ if the cash prize is not selected in each of the previous weeks.
9. All drawings will be held from the promotion desks.
10. During each scheduled drawing the winning PENN Play account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
11. Winners will be announced and winners have five (5) minutes to claim their prize with a marketing representative at the promotion desks. In the event an announced winner does not claim their prize, a redraw will be conducted. There will only be one (1) redraw per drawing hour. In the event the redraw winner does not claim the prize, any unclaimed prize will be forfeit from the prize pool.
12. On Saturday, April 27, 2024, all envelopes remaining at the 10:00pm drawing will be awarded.
13. PENN Bonus Play will be credited to each winner's PENN Play account within one (1) hour of being awarded. Winners can simply insert their PENN Play card into any VLT machine and enter their PIN to download PENN Bonus Play prizes.
14.PENN Bonus Play credits will be valid for thirty (30) days and expire at $11: 59 \mathrm{pm}$ on the final valid date.
15. PENN Bonus Play prizes are not subject to any federal, state, and local taxes.

## General Rules

1. Participants agree to the use of his or her first name, city \& state and photograph for advertising and promotional purposes without charge or additional compensation.
2. Persons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
3. Employees of Hollywood Gaming at Mahoning Valley Race Course, its subsidiaries, affiliates, or parent companies, and those family members who reside in the same household are not eligible to participate in this promotion.
4. Hollywood Gaming at Mahoning Valley Race Course is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail.

7. Hollywood Gaming at Mahoning Valley Race Course reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or a complimentary reward has been changed, altered or tampered with in any way.
8. Use of the PENN Play card indicates acceptance of these Official Rules.
9. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
10. Any change or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
11. Winners are responsible for all applicable federal, state, and local taxes, title and licensing fees.
12. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.
