Winners' Celebration – Official Rules

Promotion Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a “Winners’ Celebration” on Sunday, April 28, 2024, beginning at 1:00pm and concluding at 4:00pm.
2. A total of sixteen (16) winners will be randomly selected and awarded cash or PENN Bonus Play during the promotion.
3. All winners will be selected and awarded prizes at 1:00pm, 2:00pm, 3:00pm, and 4:00pm on the date of the promotion.
4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

1. Open to invited guests with a PENN Play card.
2. Invited guests must meet one of the following eligibility requirements:
 - a. Won a hand paid jackpot at Hollywood Gaming Mahoning Valley from March 1, 2024, to March 31, 2024. Hand paid jackpots are one thousand two hundred dollars (\$1,200) or greater.
 - a. Won a promotional prize at Hollywood Gaming Mahoning Valley between March 1, 2024, to March 31, 2024.
3. PENN Play members will receive an electronic entry for each eligible jackpot or promotional win.
4. Invited guests must activate their entry or entries within thirty (30) minutes of each drawing time to be eligible by swiping at a marketing kiosk or properly removing their PENN Play card from a VLT machine.
5. Must be 21 years of age or older to obtain a PENN Play card.
6. No purchase is necessary to receive a PENN Play card.
7. A valid government issued photo ID is required upon request to verify age and identity.
8. Eligible guests can win one (1) time per drawing date.

Drawing:

1. Four (4) names will be electronically selected each hour starting at 1:00pm and ending at 4:00pm.
2. There will be four (4) game spots on the electronic game board. In the event of a technical malfunction, four (4) envelopes in a drum will be used as an alternative game.
3. Winners will select the electronic game piece or envelope to reveal their prize in the order in which they were called.

2. Winners' names and PENN Play account numbers will be announced via the facility paging system. Information will also be displayed on select video screens throughout the property.
3. Winners must be present to win and have five (5) minutes to claim their prize with a marketing representative at the promotion desks.
4. In the event a winner is not present after five (5) minutes, there will be up to three (3) redraws. Redraw winners will have three (3) minutes to claim their prize at the promotions desk. All unclaimed prizes will be forfeited from the prize pool.
5. PENN Bonus Play will be awarded to the winner's account within one (1) hour of each drawing. Should a technical difficulty occur, the PENN Bonus Play will be awarded to the winner's account within twenty-four (24) hours.
6. PENN Bonus Play credits may be downloaded in partial increments as playable credits on any VLT machine. Once downloaded, unused credits will expire within twenty-four (24) hours.
7. PENN Bonus Play credits will be valid for thirty (30) days and expire at 11:59pm on the final valid date.
8. PENN Bonus Play prizes are not subject to any federal, state, and local taxes.

General Rules

1. Participants agree to the use of his or her first name, city & state, and photograph for advertising and promotional purposes without charge or additional compensation.
2. Persons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
3. Employees of Hollywood Gaming at Mahoning Valley Race Course, its subsidiaries, affiliates, or parent companies, and those family members who reside in the same household are not eligible to participate in this promotion.

9. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
10. Any change or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
11. Winners are responsible for all applicable federal, state, and local taxes.

In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.
