



Valentine's Candy Bar Giveaway – Official Rules

Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a "Valentine's Candy Bar Giveaway" promotion on Thursday, February 7, 2019 and Thursday, February 14, 2019 from 2:00 pm to 7:00pm.
2. All times referred to throughout these rules are Eastern Standard Time (EST).
3. Promotion Dates and Times:
 - February 7, 2019, 2:00pm-7:00pm
 - February 14, 2019, 2:00pm-7:00pm

Eligibility

1. Open to all Marquee Rewards® Members.
2. Must be 21 years of age or older to obtain a Marquee Rewards card.
3. No purchase necessary to receive a Marquee Rewards card.
4. A valid and current government issued photo ID is required to verify age and identity.

Prizes

1. Every Marquee Rewards® Member will receive one (1) Candy Bar.
2. Guests can visit the promotional area in the food court from 2:00pm to 7:00pm on each promotional date to claim their candy bar.
3. All chocolate bars will have a "Golden Ticket"
 - Prize ticket winnings will range from \$5 to \$1000 in Free VLT Play.
4. Marquee Rewards members can reveal their Golden Ticket winnings in front of a Marketing Representative at the promotional tables in the Food Court promotional area to have their Free VLT Play loaded to their Marquee Rewards card immediately after receiving their candy bar.
5. Golden tickets will be honored for the duration of the promotion from February 7 at 2:00pm until February 14 at 7:00pm.
6. Free VLT Play will be credited to each winner's Marquee Rewards account within one (1) hour of being awarded. Winners can simply insert their Marquee Rewards card into any VLT machine and enter their PIN to download Free VLT Play prizes.
7. Free VLT Play credits will be valid for thirty (30) days from the day the ticket was redeemed and expire at 11:59 pm on the final valid date.
8. Free VLT Play prizes are not subject to any federal, state, and local taxes.

Earning Criteria

1. Marquee Rewards members will have the opportunity to earn additional candy bars on each promotional day.
2. Guests may earn up to two (2) additional candy bars for every one-hundred (100) tier points earned on each promotional day.
3. Tier points must be earned between 5:00am and 7:00pm on each promotional day to be eligible for the additional candy bars.

General Rules

2. Any patrons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
