

Stocking Stuffer Swipe & Win - Official Rules

Promotion Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will host a "Stocking Stuffer Swipe & Win" promotion on Tuesdays in December beginning on Tuesday, December 1, 2020 at 9:00am and concluding on Tuesday, December 29, 2020 at 9:00pm.
- 2. Promotion dates are as follows:
 - Tuesday, December 1, 2020
 - Tuesday, December 8, 2020
 - Tuesday, December 15, 2020
 - Tuesday, December 22, 2020
 - Tuesday, December 29, 2020
- 3. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Must be a member of the mychoice program.
- 2. Must be 21 years of age or older to obtain a mychoice card.
- 3. No purchase necessary to receive a mychoice card.
- 4. A valid government issued photo ID is required to verify age and identity.
- 5. For every fifty (50) tier points (\$250 coin-in) a guest earns through play, they can swipe at the kiosk and play the game for a chance to win a prize. The guest can play the game for a maximum of three (3) times on each designated promotional date during the promotional period.

Prizes

- 1. Upon swiping their mychoice card and selecting the "Stocking Stuffer Swipe & Win" promotion on the kiosk, twelve (12) prize pieces will appear. The guest will be able to select prize pieces until they find three (3) of the same prize.
- 2. The following prizes will be available on the wheel:

Position 1	\$10 Free VLT Play
Position 2	\$25 Free VLT Play
Position 3	\$100 Free VLT Play
Position 4	\$1,000 Free VLT Play

- 3. In the event of a system failure, any prizes won through the kiosk will be updated onto a guest's account within seventy-two (72) hours.
- 4. Free VLT Play will be credited to each winner's mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
- 5. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59pm on the final valid date.
- 6. In the event of an unforeseen system outage or network problem, Free VLT Play credits will be added to each winner's mychoice account within twenty-four (24) hours of being awarded.
- 7. Free VLT Play prizes are not subject to any federal, state, and local taxes.

8. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management's discretion.

General Rules

- 1. Participants agree to the use of his or her first name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
- 2. Any patrons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
- 3. Employees of Hollywood Gaming at Mahoning Valley Race Course, its subsidiaries, affiliates, or parent companies, and those family members who reside in the same household are not eligible to participate in this promotion.
- 4. Hollywood Gaming at Mahoning Valley Race Course is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail.
- 5. Program benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Gaming at Mahoning Valley Race Course.
- 6. Hollywood Gaming at Mahoning Valley Race Course may disqualify any person based upon fraud, dishonesty, and violation of program rules or other misconduct.
- 7. Hollywood Gaming at Mahoning Valley Race Course reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or a complimentary reward has been changed, altered or tampered with in any way.
- 8. Use of the mychoice card indicates acceptance of these Official Rules.
- 9. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
- 10. Any change or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
- 11. Winners are responsible for all applicable federal, state, and local taxes, title and licensing fees.
