



The Ultimate Derby Experience Sweepstakes – Official Rules

Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct “The Ultimate Derby Experience Sweepstakes” promotion on Saturdays in March. The promotional period will begin on Monday, March 1, 2021 at 5:00am and will end at 8:00pm on Saturday, March 27, 2021.
2. A total of eighty (80) winners will be randomly selected during the promotional period.
3. Four (4) winners will be selected and awarded a prize approximately every hour starting at 4:00pm and ending approximately at 8:00pm on the following dates:
 - Saturday, March 6, 2021
 - Saturday, March 13, 2021
 - Saturday, March 20, 2021
 - Saturday, March 27, 2021
4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

1. Must be a member of the mychoice program.
2. Must be 21 years of age or older to obtain a mychoice card.
3. No purchase necessary to receive a mychoice card.
4. A valid government issued photo ID may be required to verify age and identity.
5. Qualifying mychoice members can win a total of one (1) time per drawing date on March 6, 13 & 20, 2021. On the finale date, Saturday, March 27, 2021, qualifying mychoice members can win a total of two (2) times. Guests can win one (1) prize during the drawings between 4:00pm and 7:00pm and one (1) prize during the 8:00pm finale drawing.

Earning Entries

1. For every two (2) tier points earned (\$10 coin-in) through play, mychoice members will earn one (1) entry.
2. Entry earning will begin at 5:00am on March 1, 2021 and will end at 8:00pm on March 27, 2021.
3. Guests will earn ten (10) times entries for all earned entries on select Mondays in March from 5:00am until 11:59pm. Ten (10) times earned entries will be applied to entries earned on the following dates:
 - Monday, March 1, 2021
 - Monday, March 8, 2021
 - Monday, March 15, 2021
 - Monday, March 22, 2021
4. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by swiping at a Marketing kiosk or be actively playing with their mychoice card at a VLT machine.
5. Earned entries up to approximately five (5) minutes before each drawing time will be included in the upcoming drawing. Earned entries may be delayed posting onto a guest’s account.
6. In the event of a technical delay or malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any issues during the malfunction/outage period will be reviewed and awarded on a case-by-case basis at management’s discretion.
7. Entries will accumulate during the entire promotional period.

Implementation

1. On each drawing date, four (4) winners will be selected approximately every hour beginning at 4:00pm and ending at 8:00pm.
2. All drawings will be held at the Food Court promotional area.
3. Winners will point to a Derby horse on the television screen and the Marketing Representative will reveal the prize. Guests will continue to select horses until they match three (3) of the same prize.
4. Guests can win Free VLT Play prizes ranging from two hundred fifty (\$250) dollars up to one thousand (\$1,000) dollars.
5. On the finale date, Saturday, March 27, 2021 at the 8:00pm drawing time, one (1) of the four (4) winners will win The Ultimate Derby Experience package. The Free VLT Play prizes for the 8:00pm drawing time will range from one thousand (\$1,000) dollars up to three thousand (\$3,000) dollars.
6. If the winner does not accept the prize, no consolation prize will be awarded, and they would forfeit the prize. Another name will be drawn until a winner is found.
7. The Ultimate Derby Experience package includes two thousand five hundred (\$2,500) Free VLT Play for use at Hollywood Gaming Mahoning Valley, airfare for two (2) guests, two (2) tickets for the Horse Tour on April 30, 2021, two (2) tickets for the Kentucky Derby on May 1, 2021 and hotel accommodations at the Hilton Garden Inn in downtown Louisville. Hotel check-in is April 29, 2021 and check out is May 2, 2021. Package is valued at twelve thousand (\$12,000).
8. If the winner of The Ultimate Derby Experience does not take a guest on the trip, no additional compensation will be provided.
9. During each scheduled drawing the winning mychoice account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
10. Winners must be present to win and will have five (5) minutes to claim their prize from the Food Court promotional area.
11. Winners must have valid government issued photo ID to claim prize.
12. In the event a winner is not present after five (5) minutes, one (1) redraw will be conducted. After the redraw, any prizes unclaimed will be forfeited.
13. Free VLT Play will be credited to each winner's mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
14. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
15. Free VLT Play prizes are not subject to any federal, state, and local taxes.

General Rules

1. Participants agree to the use of his or her first name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
2. Persons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
3. Employees of Hollywood Gaming at Mahoning Valley Race Course, its subsidiaries, affiliates, or parent companies, and those family members who reside in the same household are not eligible to participate in this promotion.
4. Hollywood Gaming at Mahoning Valley Race Course is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail.
5. Program benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Gaming at Mahoning Valley Race Course.

6. Hollywood Gaming at Mahoning Valley Race Course may disqualify any person based upon fraud, dishonesty, and violation of program rules or other misconduct.
7. Hollywood Gaming at Mahoning Valley Race Course reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or a complimentary reward has been changed, altered or tampered with in any way.
8. Use of the mychoice card indicates acceptance of these Official Rules.
9. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
10. Any change or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
11. Winners are responsible for all applicable federal, state, and local taxes, title and licensing fees.
