



\$25,000 Match Four Sweepstakes – Official Rules

Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a “\$25,000 Match Four Sweepstakes” promotion on Fridays in August. The promotional period will begin on Monday, August 1, 2022, at 5:00am and will end at 9:00pm on Friday, August 26, 2022.
2. A total of one hundred twenty (120) winners will be randomly selected during the promotional period.
3. Six (6) winners will be selected and awarded a prize approximately every hour starting at 5:00pm and ending approximately at 9:00pm on the following dates:
 - Friday, August 5, 2022
 - Friday, August 12, 2022
 - Friday, August 19, 2022
 - Friday, August 26, 2022
4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

1. Must be a member of the mychoice program.
2. Must be 21 years of age or older to obtain a mychoice card.
3. No purchase necessary to receive a mychoice card.
4. A valid government issued photo ID is required upon request to verify age and identity.
5. Qualifying mychoice members can win a total of one (1) time per drawing date.

Earning Entries

1. For every two (2) tier points earned (\$10 coin-in) through play, mychoice members will earn one (1) entry.
2. Entry earning will begin at 5:00am on August 1, 2022 and will end at 9:00pm on August 26, 2022.
3. Guests will earn ten (10) times entries for all earned entries on select Mondays in August 2022. Ten (10) times earned entries will be applied to entries earned on the following dates:
 - Monday, August 1, 2022, 5:00am-11:59pm
 - Monday, August 8, 2022, 5:00am-11:59pm
 - Monday, August 15, 2022, 5:00am-11:59pm
 - Monday, August 22, 2022, 5:00am-11:59pm
4. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by either swiping at a mychoice kiosk, carding out of a VLT machine via Bluetooth connectivity in the mychoice app or by properly carding out from a VLT machine.
5. Earned entries up to approximately five (5) minutes before each drawing time will be included in the upcoming drawing. Earned entries may be delayed posting onto a guest’s account.
6. In the event of a technical delay or malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any issues during the malfunction/outage period will be reviewed and awarded on a case-by-case basis at management’s discretion.
7. Entries will accumulate during the entire promotional period.

Implementation

1. On each drawing date, six (6) winners will be selected approximately every hour beginning at 5:00pm and ending at 9:00pm.
2. All drawings will be held at the Food Court promotional area.
3. Guests will be awarded the following prizes in the order in which they were called. In the event a winner is not present, all winning guests that have claimed will be moved up on the prize chart.
4. In the event a winner is not present after five (5) minutes, one (1) redraw will be conducted. After the redraw, any prizes unclaimed will be forfeited.
5. During each scheduled drawing the winning mychoice account number along with the winner’s first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
6. Winners must be present to win and will have five (5) minutes to claim their prize from the Food Court promotional area.
7. Prizes will be awarded in the following order with the first winner playing the Match Four game and subsequent winners of the two hundred fifty (\$250) Free Play prize.

1. During the Match Four game, forty (40) envelopes will be on the prize board.
2. Winners must select envelopes until they match four (4) of the same prize values. The first four (4) prize values matched will determine the cash or Free Play prize awarded to the winner.

In the event the top prize of twenty-five thousand dollars (\$25,000) cash is awarded via the match four game, the subsequent prize for matching four (4) twenty-five thousand (\$25,000) prize cards will be ten thousand (\$10,000) Free VLT Play. Only (1) one \$25,000 twenty-five dollars cash prize can be awarded throughout the promotional period.

5. Free VLT Play will be credited to each winner’s mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
6. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
7. Free VLT Play prizes are not subject to any federal, state, and local taxes.
8. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management’s discretion.

General Rules
