



## Tour of High Limits Sweepstakes- Official Rules

### Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will hold a “Tour of High Limits Sweepstakes” promotion on Saturday, August 27, 2022 from 1:00pm-3:00pm and then again from 7:00pm-9:00pm.
2. Entry accumulation will begin on Monday August 1, 2022, at 5:00am and will end on Saturday August 27, 2022, at 9:00pm.
3. A total of sixty (60) winners will be randomly selected and awarded prizes during the promotion, ten (10) winners will be selected and awarded prizes hourly beginning at 1:00pm-3:00pm and again from 7:00pm-9:00pm.
4. All times referred to throughout these rules are Eastern Standard Time (EST).

### Eligibility

1. Open to all mychoice members, must be 21 years of age or older to obtain a mychoice card.
2. Entries will accumulate all month.
3. One (1) entry is earned through every two (2) tier points earned or every ten dollars (\$10) coined through the VLT machines.
4. Entries will be electronic.
5. Eligible guests must activate their entries within thirty (30) minutes prior to each drawing time one of the following ways:
  - Properly carding out of a VLT machine
  - Card out of a VLT machine by disconnecting Bluetooth connection via the mychoice app
  - Swipe at a mychoice kiosk
6. No purchase necessary to receive a mychoice card.
7. A valid government issued photo ID must be shown upon request to verify age and identity.

### Preliminary

1. Ten (10) winners will be selected at 1PM, 2PM, 7PM and 8PM each to receive \$200 Free VLT Play.
2. In the event a prize goes unclaimed, there will be one redraw conducted. Any prizes after the redraw left unclaimed will be forfeited.
3. During each scheduled drawing, the winning mychoice account number along with the winner’s first name and last initial will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
4. Winners must be present and have five (5) minutes to claim their prize at the promotions table located in the Food Court.
5. Eligible guests may win one (1) preliminary drawing and one (1) Grand Finale drawing on the promotional date.
6. Free VLT Play will be credited to each winner’s mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
7. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
8. Free VLT Play prizes are not subject to any federal, state, and local taxes.
9. In the event of a technical malfunction or outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Hollywood Gaming at Mahoning Valley Race Course is not responsible for offers and prizes not used or redeemed due to the malfunction or outage and during the malfunction or outage period. Offers and prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management’s discretion.

### Grand Finale

10. At 3:00pm and 9:00pm, one (1) winner will be called to take a tour of High Limits where they will be given three (3) max bet spins on each VLT machine. If the winner has the mywallet function set up in the mychoice app at the time of the drawing, they will be given five (5) spins on each VLT machine.
11. The first guest announced at 3:00pm and 9:00pm will be selected to take the tour of High Limits. The remaining nine (9) guests announced at 3:00pm and 9:00pm will be awarded two hundred dollars (\$200) Free VLT Play.
12. High Limits includes the following assets: A01, A08 & A09, where the guest will bet max bet on each one of the VLT machines.
13. In the event the first guests announced does not claim their prize, all other guests will be moved up on the prize chart. No redraws will be conducted for the Grand Finale drawings.
14. Eligible guests may only win one (1) Grand Finale drawing on the promotional date.
15. In the event a guest does not win any credits while on the Tour of High Limits, a consolation prize will be issued in the amount of five hundred \$500 Free VLT Play.
16. In the event that one of the VLT machines is out of service, or VLT machine is occupied by another guest, the high limit winner will be play another VLT machine that is equal in denomination and value.
