



Game Show Swipe & Win – Official Rules

Promotion Period

1. Hollywood Gaming at Mahoning Valley Race Course will host an “Game Show Swipe & Win” promotion on Tuesdays in February beginning at 9:00am on Tuesday February 7, 2023 and concluding at 9:00pm on Tuesday, February 27, 2023.
2. Promotion dates are as follows:
 - Tuesday, February 7, 2023
 - Tuesday, February 14, 2023
 - Tuesday, February 21, 2023
 - Tuesday, February 27, 2023
3. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

1. Must be a member of the mychoice program.
2. Must be 21 years of age or older to obtain a mychoice card.
3. No purchase necessary to receive a mychoice card.
4. A valid government issued photo ID is required to verify age and identity.
5. For every fifty (50) tier points (\$250 coin-in) a guest earns through play, they can swipe at the kiosk and select a virtual game on a mychoice kiosk to reveal their Free Play prize. The guest can swipe for a maximum of three (3) times per promotional date during the promotional period.

Prizes

1. Upon swiping their mychoice card and selecting the “Swipe & Win” promotion on the kiosk, “Sticker to Peel” will appear on the screen. The guest will have to select one (1) snowflake to reveal their Free VLT Play prize.
2. The following prizes will be available:

Position 2	\$10 Free VLT Play
Position 3	\$15 Free VLT Play
Position 4	\$25 Free VLT Play
Position 5	\$100 Free VLT Play
Position 6	\$1,000 Free VLT Play

3. In the event of a system failure, any prizes won through the kiosk will be updated onto a guest’s account within seventy-two (72) hours.
4. Free VLT Play will be credited to each winner’s mychoice account within one (1) hour of being awarded. Winners can simply insert their mychoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.
5. Free VLT Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
6. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those
