Virtual Pull Tabs - Official Rules

Promotional Period

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a “Winter Wonderland Pull Tabs” promotion on Thursdays in January, beginning on January 5, 2023 at 6:00am and concluding on Thursday, January 26, 2023 at 11:59pm.
2. Invited guests will receive a virtual pull tab that they can claim at a Marketing kiosk. The offer claimed through the Marketing kiosk will be valid on the following dates:
 - Thursday, January 5, 2023 6:00am-11:59pm
 - Thursday, January 12, 2023 6:00am-11:59pm
 - Thursday, January 19, 2023 6:00am-11:59pm
 - Thursday, January 26, 2023 6:00am-11:59pm
3. Guests will have from 6:00am until 11:59pm on each promotion date to claim and use their offer. Any offer that is not claimed at a Marketing kiosk and or used within the time frame of 6:00am-11:59pm will be forfeited.
4. Free VLT Play credits will be valid for the specific promotion date only and will expire at 11:59pm at the end of each promotional date (11:59pm on January 5, 11:59pm on January 12, 11:59pm on January 19, 11:59pm & 11:59pm on January 26, 2022).
5. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

1. Must be a member of the mychoice program.
2. Must be 21 years of age or older to obtain a mychoice card.
3. No purchase necessary to receive a mychoice card.
4. A valid government issued photo ID is required upon request to verify age and identity.
5. Eligible mychoice members will be invited by mail or email and the invite and Free VLT Play offer will be determined by historical level of play factors including but not limited to trip frequency, VLT machine denominations played, average bet, length of play, and length of time since last visit.
6. Each invited guest will have one valid virtual pull tab offer per promotion date.
7. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management’s discretion.

General Rules

1. Participants agree to the use of his or her first name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
2. Free VLT Play will expire at 11:59PM on each promotion date.
3. Any patrons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
4. Employees of Hollywood Gaming at Mahoning Valley Race Course, its subsidiaries, affiliates, or parent companies, and those family members who reside in the same household are not eligible to participate in this promotion.

5. Hollywood Gaming at Mahoning Valley Race Course is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail or email.
6. Program benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Gaming at Mahoning Valley Race Course.
7. Hollywood Gaming at Mahoning Valley Race Course may disqualify any person based upon fraud, dishonesty, and violation of program rules or other misconduct.
8. Hollywood Gaming at Mahoning Valley Race Course reserves the right to refuse complimentary redemptions if it is determined that the true cardholder is not present or that coupons or a complimentary reward has been changed, altered or tampered with in any way.
9. Use of the mychoice card indicates acceptance of these Official Rules.
10. Any dispute or situation not covered by the above rules will be resolved by Management in a manner deemed by them to be the fairest outcome for all concerned. That decision shall be final and binding. In addition, Hollywood Gaming at Mahoning Valley Race Course reserves the right to change, modify or cancel this program at any time.
11. Any change or cancellation of the program must be approved by the Ohio Lottery Commission prior to the change or cancellation.
