



## **PENN Millionaire Sweepstakes – Official Rules**

### **Promotional Period**

1. Hollywood Gaming at Mahoning Valley Race Course will conduct a “PENN Millionaire Sweepstakes” promotion on Saturday, March 25, 2023. The promotional earning period will begin on Wednesday, March 1, 2023 at 5:00am and will end at 9:00pm on Saturday, March 25, 2023.
2. Fifty (50) winners will be randomly selected during the promotional period.
3. Ten (10) winners will be selected and awarded a prize approximately every hour starting at 5:00pm and ending approximately at 9:00pm on the following dates:
  - Saturday, March 25, 2023
4. All times referred to throughout these rules are Eastern Standard Time (EST).

### **Eligibility**

1. Must be a member of the mychoice program.
2. Must be 21 years of age or older to obtain a mychoice card.
3. No purchase necessary to receive a mychoice card.
4. A valid government issued photo ID may be required to verify age and identity.
5. Qualifying mychoice members can win a total of one (1) time during the 5:00pm through 8:00pm drawings and one (1) time during the 9:00pm finale drawing on March 25, 2023.

### **Earning Entries**

1. For every two (2) tier points earned (\$10 coin-in) through play, mychoice members will earn one (1) entry.
2. Entry earning will begin at 5:00am on March 1, 2023 and will end at approximately 8:55pm on March 25, 2023.
3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by swiping at a Marketing kiosk or properly removing their mychoice card from a VLT machine.
4. Earned entries up to approximately five (5) minutes before each drawing time will be included in the upcoming drawing. Earned entries may be delayed posting onto a guest’s account.
5. Entries will accumulate during the entire promotional period.
6. In the event of a kiosk or technical malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any games or prizes being played or awarded at the time of the malfunction will be honored and resolved within twenty-four (24) hours. Hollywood Gaming at Mahoning Valley Race Course is not responsible for games not played due to the malfunction/outage and during the malfunction/outage period, as well as any subsequent prizes from those games. Prizes not redeemed during the malfunction period will be reviewed and awarded on a case-by-case basis at management’s discretion.

During each scheduled drawing the winning mychoice account number along with the winner’s first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
5. Winners will be announced and after five (5) minutes, the free play prize will be loaded onto their mychoice account.
6. No redraws will be conducted for the drawing times.
