

# \$25,000 Match Four Sweepstakes - Official Rules

#### **Promotional Period**

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a "\$25,000 Match Four Sweepstakes" promotion on Saturdays in June, 2025. The promotional period will begin on Saturday, June 7, 2025, at 5:00am and will end at 9:00pm on Saturday, June 28, 2025.
- 2. A total of ninety-six (96) winners will be randomly selected during the promotional period.
- 3. Six (6) winners will be selected and awarded a prize approximately every hour starting at 6:00pm and ending approximately at 9:00pm on the following dates:
  - Saturday, June 7, 2025
  - Saturday, June 14, 2025
  - Saturday, June 21, 2025
  - Saturday, June 28, 2025
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

#### Eligibility

- 1. Must be a member of the PENN Play program.
- 2. Must be 21 years of age or older to obtain a PENN Play card.
- 3. No purchase is necessary to receive a PENN Play card.
- 4. A valid government issued photo ID is required upon request to verify age and identity.
- 5. Qualifying PENN Play members can win a total of one (1) time per drawing date.

### **Earning Entries**

- 1. For every two (2) tier points earned (\$10 coin-in) through play, PENN Play members will earn one (1) entry.
- 2. Entry earnings will begin at 5:00am on June 1, 2025, and will end at 9:00pm on June 28, 2025.
- 3. Members must activate their entries within thirty (30) minutes of each scheduled drawing time on each drawing date by either swiping at a marketing kiosk, carding out of a VLT machine via Bluetooth connectivity in the rewards app or by properly carding out from a VLT machine.
- 4. Earned entries up to approximately five (5) minutes before each drawing time will be included in the upcoming drawing. Earned entries may be delayed posting onto a guest's account.
- 5. In the event of a technical delay or malfunction/outage, Hollywood Gaming at Mahoning Valley Race Course reserves the right to temporarily discontinue the promotion until a reasonable solution has been determined and implemented. Any issues during the malfunction/outage period will be reviewed and awarded on a case-by-case basis at management's discretion.
- 6. Entries will accumulate during the entire promotional period.

#### <u>Implementation</u>

- 1. On each drawing date, six (6) winners will be selected approximately every hour beginning at 6:00pm and ending at 9:00pm.
- 2. All drawings will be held from the promotions desk.
- 3. Guests will be awarded the following prizes in the order in which they were called. In the event a winner is not present, all winning guests that have claimed will be moved up on the prize chart.

- 4. In the event a winner is not present after five (5) minutes, one (1) redraw will be conducted. After the redraw, any prizes unclaimed will be forfeited.
- 5. During each scheduled drawing the winning PENN Play account number along with the winner's first name and first initial of their last name will be announced on the gaming floor public address system. The same information will also be posted on large projection screens and other monitors throughout the gaming floor.
- 6. Winners must be present to win and will have five (5) minutes to claim their prize at the promotions desk.
- 7. Prizes will be awarded in the following order with the first winner playing the Match Four game and subsequent winners of the two hundred fifty (\$250) PENN Bonus Play prize.

- 8. During the Match Four game, forty (40) envelopes will be on the prize board.
- 9. Winners must select envelopes until they match four (4) of the same prize values. The first four (4) prize values matched will determine the cash or PENN Bonus Play prize awarded to the winner.
- 10. On Saturday, June 28, all prizes will be doubled for the Match Four Game and subsequent prizes. The prizes in the below and above charts will be doubled. The doubled amounts will result in the Match Four minimum prize being one thousand (\$1,000) PENN Bonus Play up to fifty thousand (\$50,000) cash. The prizes for winners two (2) through six (6) in the above prize chart are non-Match Four game playing winners and will win five hundred (\$500) PENN Bonus Play as a result of the original two hundred fifty PENN Bonus Play (\$250) prize being doubled.
- 11. In the event the top prize of twenty-five thousand dollars (\$25,000) cash is awarded via the match four game, the subsequent prize for matching four (4) twenty-five thousand (\$25,000) prize cards will be ten thousand (\$10,000) PENN Bonus Play. Only (1) one \$25,000 twenty-five thousand dollars cash prize can be awarded throughout the promotional period.

- 13. PENN Bonus Play will be credited to each winner's PENN Play account within one (1) hour of being awarded. Winners can simply insert their PENN Play card into any VLT machine and enter their PIN to download PENN Bonus Play prizes.
- 14. PENN Bonus Play credits will be valid for thirty (30) days and expire at 11:59 pm on the final valid date.
- 15. PENN Bonus Play prizes are not subject to any federal, state, and local taxes.

### **General Rules**

- 1. Participants agree to the use of his or her first name, city & state and photograph for advertising and promotional purposes without charge or additional compensation.
- 2. Persons on the Hollywood Mahoning Exclusion List are not eligible to participate in any promotional programs.
