Loyalty Gift Giveaway - Official Rules

Promotional Period

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a "Loyalty Gift Giveaway" on Sunday, January 19, 2020.
- 2. This promotion shall begin at 11:00 am and end at 5:00 pm.
- 3. Guests can begin swiping their MyChoice card at marketing kiosks at 11:00 am to receive their gift voucher. Guests can redeem their voucher in lower level racing between 12:00 pm and 5:00 pm. Owners Club and Elite members can begin redeeming their gifts at 11:00 am.
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Eligible MyChoice members will be invited by email and/or mail and determined by historical level of play factors including but not limited to trip frequency, VLT machine denominations played, average bet, length of play, and length of time since last visit.
- 2. Guests may pick up their gift in the Trackside Level Promotional Area on the promotion date.
- 3. MyChoice members that do not receive an invite as a loyalty member will have the opportunity to earn two hundred (200) tier points (\$1,000 coin-in) on the day of the promotion between 5:00 am and 4:59 pm to earn a gift.
- 4. Invited MyChoice members will also have the opportunity to earn two hundred (200) tier points (\$1,000 coin-in) on the day of the promotion between 5:00 am and 4:59 pm to earn up to one (1) additional gift.
- 5. Only the guest whose name appears on the gift voucher will be able to pick up their gift(s).
- 6. A valid and current government issued photo ID is requires to verify age and identity.
- 7. Gifts will be available while supplies last.
- 8. Approximately two thousand five-hundred (2,500) gifts are available on the promotion day.
- 9. In the event that Hollywood Gaming at Mahoning Valley runs out of gifts, the guest will receive a leftover gift from a previous gift giveaway. This determination will be made by Hollywood Gaming Mahoning Valley.
- 10. Due to the volume of guests in line for gift redemption, management reserves the right to begin the gift redemption up to one (1) hour early.
