

<u>Promotional Period</u>

- 1. Hollywood Gaming at Mahoning Valley Racecourse will conduct a "MySummer Mercedes Giveaway" promotion beginning at 12:00am, Monday, July 1, 2019 and continuing through 8pm on Saturday, August 31, 2019.
- 2. A total of one-hundred seventy-two (172) winners will be randomly selected and awarded prizes.
- 3. Giveaway dates and times:

 - o Saturday, August 10, 2019
 - o Saturday, August 17, 2019
 - o Saturday, August 24, 2019
 - o Saturday, August 31, 2019
 - Winners will be selected every hour during the preliminary drawing dates from 4:00pm-8:00pm. On the grand prize drawing date, August 31, there will be preliminary drawings from 4:00pm-7:00pm.
 - The Grand Prize drawing will take place at 8:00pm on August 31 where four (4) winners will be selected.
- 4. All times referred to throughout these rules are Eastern Standard Time (EST).

Eligibility

- 1. Must be a member of the MyChoice program.
- 2. Must be 21 years of age or older to obtain a MyChoice card.

- 1. Winners must have valid photo ID to claim prize.
- 2. Winners' names and MyChoice numbers will be announced via the facility paging system. Information will also be displayed on select video screens throughout the property.
