

# Golden Ticket Candy Bar Giveaway – Official Rules

### **Promotional Period**

- 1. Hollywood Gaming at Mahoning Valley Race Course will conduct a "Golden Ticket Candy Bar Giveaway" promotion on select Thursdays in July from 2:00 pm to 8:00pm.
- 2. All times referred to throughout these rules are Eastern Standard Time (EST).
- 3. Promotion Dates and Times:
  - July 11, 2019, 2:00pm-8:00pm
  - July 18, 2019, 2:00pm-8:00pm

### Eligibility

- 1. Open to all MyChoice members.
- 2. Must be 21 years of age or older to obtain a MyChoice card.
- 3. No purchase necessary to receive a MyChoice card.
- 4. A valid and current government issued photo ID is required to verify age and identity.

#### **Prizes**

- 1. The following prizes will be awarded:
  - o Every MyChoice member will receive a specified number of Candy Bars
  - Guests can visit the promotional area in the food court from 2:00pm to 8:00pm on each promotional date to claim their candy bars.
  - The quantity of Candy Bars received is dependent on the MyChoice member's tier level.
    - Choice Rewards cardholders will receive one (1) Chocolate bar.
    - Advantage cardholders will receive two (2) Chocolate Bars.
    - Preferred cardholders will receive three (3) Chocolate Bars.
    - Elite cardholders will receive four (4) Chocolate Bars.
    - Owners Club cardholders will receive five (5) Chocolate bars.
  - 1 in 5 chocolate bars will have a "Golden Ticket"
    - Prize ticket winnings will range from \$15 free play to \$1000 in cash.
  - If the MyChoice member receives a chocolate bar with a Golden Ticket they will take the ticket to Player Services to have their prize amount loaded onto their player's card.
  - Golden tickets will be honored for the duration of the promotion from July 11 at 2:00pm until July 18 at 11:59pm.
  - Free VLT Play will be credited to each winner's MyChoice account within one (1) hour of being awarded. Winners can simply insert their MyChoice card into any VLT machine and enter their PIN to download Free VLT Play prizes.

- Free VLT Play credits will be valid until the end of the month (Wednesday, July 31)
  and will expire at 11:59 pm on the final valid date.
- o Free VLT Play prizes are not subject to any federal, state, and local taxes.

#### **General Rules**
